## Day of Discovery—What's That?

To help launch your search for your next pastor, the Northern California Nevada Conference offers to provide leadership for a process by which your entire congregation can have energizing, positive input to guide your Ministerial Search Committee.

Day of Discovery **implements** the process of *The Appreciative Way*, a congregation-based version of *Appreciative Inquiry*, a widely used system based on the assumption

that in every organization something works and change can be managed through identification of what works and the analysis of how to do more of what works.

Day of Discovery **invites** all members and friends of your congregation to come together and discuss their love of the church, the values and practices that have sustained your congregation, and hopes and dreams for the future that all can share. By beginning to identify a future direction based on past successes and common values, your leadership and search committee has needed information to find the best pastoral leadership to take you where you want to go.

Day of Discovery **includes** a congregational meeting of approximately three hours in length. Ideas will be suggested to get input from church members who are unable to attend and maximize participation of those who cannot be present for the entire event. It is recommended that the event be held on a Saturday morning or after Sunday worship with snacks and drinks provided.

Consultant costs for your Day of Discovery and follow up with your consultant are covered by the Conference as part of the services provided to assist you in successfully completing your pastoral search process. The funds to support this ministry come from the Strengthen the Church special offering.

Local Churches who have participated in a Day of Discovery to launch their pastoral search, or as a visioning tool at any point in the life of the church, have experienced a heightened sense of positive energy for their future work. Their direction is clearer because the Appreciative process is based on past successes, the best experiences of members, positive qualities that are already present, and shared dreams for the future.

Our consultant, Rev. Daniel Ross-Jones, Associate Conference Minister will be the leader for our Day of Discovery event and will assist in a study of the collected infor-

## Outreach

### *Neighbors in Need Special Offering*

Our annual Neighbors in Need (NIN) Special Offering will be received on World Communion Sunday, October 1, 2017.

One-third of this offering supports the Council for American Indian Ministry (CAIM) and two-thirds is administered by Justice and Witness Ministries to support a variety of justice initiatives, advocacy efforts and direct service projects through grants. ### *Report from the Day Room*

Exciting things have been happening this quarter! With our great colleagues and fellow volunteers, we are now starting into our third year with teaching our classes on Life Skills.

We had a Staff Support Committee meeting two months ago in the new Autumn House, the Victorian house at the intersection of Julian St and Autumn Court. Offices for the senior counselors were moved to Autumn House, plus we acquired a meeting room.

Since a couple of offices at the JSI facility were vacated, one room now has an additional 8 clients bringing the JSI bed count to 180 (it used to be 172 (not 171 as advertised). The county was very happy about that and will buy

the Autumn House from Life Moves eventually making it county property.

The JSI Support Committee tries to help the recurring problem of low morale among the junior staff there. Low Staff Morale results from are low pay (some staff must have additional jobs), cost of housing, stress and constant crises with clients. Because the crucial junior staff has no offices, no place to have privacy, store their purses, store their lunch etc. JSI management decided the extra office would become a staff “lounge” with personal storage lockers, a sofa, and a refrigerator.

We volunteered to provide a new apartment sized refrigerator. Our Church Outreach Committee was given an opportunity to pay for it, or Connie and I would. Our colleague Alie Saad contributed “One Benjamin” (\$100 bill) to the refrigerator (total cost of \$545 with my veteran discount at HD.) Halie Greenroad selected the refrigerator and it was delivered the following Monday. The JSI Staff are most grateful and wished us to thank the church. David Canha is providing lockers. Alie found a sofa, a picture of which was sent to Halie with dimensions. It was perfect. Alie convinced the lady selling it that she really should just donate it to the shelter, which she did. Alie rented a truck and we soon had a truck load of great teenagers from Alie’s Mosque to help. I really enjoyed the chatter of the 3 friends and cousins as we stopped for lunch. It was interesting to hear the discussions of Muslim teenage boys, their aspirations for college. They were typical American kids. We delivered the sofa which is very comfortable.

The classes continue to be most rewarding. There are always new students and new problems. One of the things we suggest is they do volunteer work while looking for a job. One young woman who did that, said at the next class she had volunteered to work at the Salvation Army and they had accepted her. A couple of weeks later she told the class that the Salvation Army offered her a permanent job. She said they liked her personality and work ethic.

We have another student who is now working at Burger King as a manager and enjoying it.

We sometimes get involved with complicated problems as a part of life skills. We have to be very careful how we deal with them and we have caused ourselves problems. One young man started a tech course by correspondence many years ago, then dropped out. He has been hounded for years by the “school” and collection agencies while the interest on the loan continues to grow. Whenever he puts money in a bank, it is seized by the school, or his paycheck gets garnisheed and he loses the job. He needs a lawyer to get him some relief or he needs money. Another client, a young man, was “high” at a dance and pinched a woman on the butt. She called the police, he was arrested and it made the papers along with an exaggerated version of what happened. His Public Defender suggested he plead “no contest” saying it would keep him out of jail. He pleaded no contest. He lost his job immediately and made the sex offender list which is now a nightmare for him. Alie is trying to get him legal help as we believe his version of the story and think he should have had better representation. Alie is looking for a pro bono attorney for him.

These are the seemingly hopeless places our clients sometimes find themselves in.

I am proud of the effect our class discussions have on shaping thinking. We have had clients in the class who tell us they will never be able to work because they are always hearing voices. We had a long conversation with a student recently who hears voices, His family owned a fish business in Santa Cruz for many years, founded by his grandfather. The grandfather began hearing voices so intensely that he quit working and turned the business over to his son, the father of our student. When that man also began hearing voices so badly he couldn't work, he gave the business to our student, his son.

Our student began hearing voices and had to sell the business. He wants to contact the competitor/company he sold the business to, whom he knows quite well, and see if they will hire him to work in the mornings cleaning fish. They are well aware of and sympathetic to the family illness. He told me he hears voices mostly when he gets tired or stressed, and thinks with his medication he can work mornings and be ok. I commended him for managing his illness that way. He said his case manager supports his plan. We encourage everyone doing something useful with our lives, something more than sitting on a curb smoking cigarettes, even if we do have SSDI!

We frequently hear that Judge Manley likes it and likes to see the certificates in his drug court. We have issued around 70 since we started, 16 since January. The program is the result of work done by Ted Feely, Saleem Qadir, Alie Saad, Lesley Emma, Connie, Kevin Williams, and me. A special tip of the hat to Ted who wrote a number of lessons we are still using unchanged despite many others being revised. Connie was especially instrumental in guiding a major shift in the direction we took as soon as she came on board. Saleem Qadir brought a lot of current thinking to job hunting.

We are always looking for information from resources; simple things such as asking an Albertson's store cashier how stressful her job was. She said it was highly stressful, but only because of the occasional jerks she had to deal with each day. On a brighter side. Connie and I met the HR Manager for a major cleaning service company which will be hiring in San Jose. She said the handicapped and former offenders are excellent employees and they welcome them. They work hard, pay attention and are thankful to have a job which they want to keep. She will be a resource for us.

## Activities

### *Headlight Polishing Highlights*

A few pieces of data and interesting things to share. We had an outstanding event on our July event. We took in around \$500, allowing us to buy a new refrigerator for the shelter for the new staff “depressurization” room. They thank us all. Part of the refrigerator (\$100) was contributed by Dr. Alie Saad, a Life Skills colleague instructor who also convinced a neighbor to part with her very nice sofa for the lounge. Aliee also rented the truck and dug up the helpers for us to deliver the sofa, which we did!

Second little thing which happened was that I received some extra sanding pads for our Turtle Wax Headlight Restoration Kits. We run out of sanding pads before anything else and have incomplete kits left over. I made some good contacts at the Turtle Wax headquarters and discovered that the new ICE wax sold my Turtle Wax is great as a UV shields. (We are using a different product, “Blue Magic”). I made contact with their chemist and he finally told me that it is basically polyurethane clearcoat and that is what makes it so good (and why we need to let it dry). So, on that count, I have too much info and am conflicted a bit, although I think I have a plan. If the car is going directly home, we can use Blue Magic and have them let it dry. If they are going to a car wash, shopping etc, we’ll use the new product “ICE”.

Yesterday I received notice from Turtle Wax that I had won a product review contest and they would send me a \$100 gift certificate to use at Walmart, Advance Auto, O’Reillys, or Auto Zone. I had to choose. I told her we were a church and we did headlight polishing initially as a fundraiser although now as a public service also etc and our revenue all went to benefit our homeless shelter. I said I wanted to shop around and see who had best prices on Turtle Wax Lens Restoration kits and asked if I could get back to her next week. In her response she said,

*Hi Mike,*

*Absolutely! Thank you for your time and your review! It’s always great to hear how Turtle Wax is being used within communities. In addition to your gift card we’d like to send you a case of our Turtle Wax Headlight Lens Restorer Kit to help with your event. I’ll send you the case once I hear back from you with which retailer gift card would work best for you and which address I should mail the gift card and case to. Take your time this week and I can send everything to you whenever. Feel free to reach out if you have any additional questions!*

## Hurricane and Earthquake Relief Update

This hurricane season continues to bring new storms and more devastation. The United Church of Christ is responding not only to the immediate disaster at hand, but is also committed to the long-term process of rebuilding that will take years. UCC Disaster Ministries has just contributed \$10,000 toward a proactive program to prevent cholera and malnutrition in Haiti in the wake of Hurricane Irma, and to treat any instances that occur. The implementing partner is IMA World Health, which has had a significant presence in Haiti since 1998, including relationships with government and communities.
